Pursuant to R.C. 155.32 et seq, the Oil and Gas Land Management Commission provides notice that the formation and parcel described more fully below, which is owned or controlled by the State of Ohio, has been nominated for leasing for the exploration for and the development and production of oil or natural gas.

DESCRIPTION OF NOMINATED FORMATION AND PARCEL(S):

Parcel # And Location: 21 parcels containing more or less 1,460.559 acres in Athens and Moorefield TWP in Harrison County, OH and a being part of Jockey Hollow Wildlife Area. (For full list of parcels, please see Exhibit A).

Percent Ownership: 20 parcels with 100%, Undivided interest; 1 parcel with divided interest

Identified Formation: The Stratigraphic Equivalent that is the interval from the top of the Utica Shale Formation to the Base of the Utica Shale Formation, which is also the Base of the Point Pleasant Interval commonly referred to as the Utica Shale, Point Pleasant Formation.

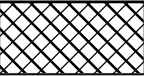

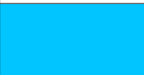
