Pursuant to R.C. 155.32 et seq, the Oil and Gas Land Management Commission provides notice that the formation and parcel described more fully below, which is owned or controlled by the State of Ohio, has been nominated for leasing for the exploration for and the development and production of oil or natural gas.

### **DESCRIPTION OF NOMINATED FORMATION AND PARCEL(S):**

**Parcel # And Location:** 8 parcels containing more or less 2792.67745 state-owned acres in Kirkwood TWP in Belmont County, OH and a being part of Egypt Valley Wildlife Area. (For full list of parcels, please see Exhibit A).


<sup>1</sup> "Tax Parcel Acreage (Gross)" refers to the total gross acreage of the tax parcel.

**Note:** While the State of Ohio – Department of Natural Resources ("ODNR") owns all of the oil and gas rights in most nominated tax parcels, it holds a divided interest in three parcels. By and through this nomination, we intend to nominate entire tax parcels where ODNR owns all of the oil and gas rights and nominate only those portions of tax parcels where ODNR holds a divided interest with the exception of Tax Parcel 12-90006.001 which is comprised of multiple non-contiguous pieces across numerous Sections.

<sup>2</sup> "Nominated Tax Parcel Acreage (Gross)" refers to the gross acreage of the tax parcel, or portion thereof, that is being nominated.

<sup>3</sup> "Nominated Tax Parcel Acreage Owned by the State (Net)" refers to the net acreage of the nominated tax parcel, or portion thereof, owned by ODNR.
