Pursuant to R.C. 155.32 et seq, the Oil and Gas Land Management Commission provides notice that the formation and parcel described more fully below, which is owned or controlled by the State of Ohio, has been nominated for leasing for the exploration for and the development and production of oil or natural gas.

DESCRIPTION OF NOMINATED FORMATION AND PARCEL(S):

Parcel # And Location: 3 parcels containing more or less 777.712 state-owned acres in Kirkwood TWP in Belmont County, OH and being part of Egypt Valley Wildlife Area (For full list of parcels, see Exhibit A).

Source Deed/Instrument: Belmont County, Ohio Recorder's Office (For full list of source deeds and instruments, see Exhibit A).

Percent Ownership: 1 parcel with 100% Undivided Interest and 2 parcels with Divided Interest

Identified Formation: The Stratigraphic Equivalent that is the interval from the Top of the Utica Formation to the Base of the Utica Formation, which is also the Base of the Point Pleasant Interval.
